Items for discussion with Phil Mulligan CEO PDNPA

What is the PDNPA vision for public transport on the A57 Snake Pass?

Organised Outdoor Events section on PDNPA website – organisers are not adhering to the code of practice. Specifically, they are not informing landowners and Parish Councils of events, but their events are still listed on the PDNPA events website. How can the PDNPA address this?

Footpaths. The PDNPA are installing gates instead of stiles on many footpaths. This has encouraged cyclists and motorbikes to use them which has caused erosion, irreparable damage, loss of habitat and widening footpaths where people walk to avoid the mud. Please can we have your comments.

UDVRE Upper Derwent Valley Reservoir Expansion Scheme

1. What is the PDNPA's overall view on expanding the Upper Derwent resources?
2. How does PDNPA view the long-term future for Fairholmes in the context that 99% of the Parish residents and 92% of visitors thought the facilities at Fairholmes were satisfactory?
3. What does PDNPA think of NT inalienable land being sold to a private water company?

4. What is going on right now – what engagement between STW & the PDNPA, what is STW saying, what is PDNPA saying - please would Phil share all the information that he can?
5. Please would Phil explain how the PDNPA will assess the proposal.
6. How will PDNPA ensure that consultation with the local community will be inclusive, timely, provide all the necessary information and give people enough time to get to grips with the complexity of the proposal?
7. How will the PDNPA ensure that the impacts of all of the options (not the single chosen option) on the environment and people will be presented to them?
8. Is the PDNPA envisaging access to the reservoirs for water sports as has happened in other areas such as Carsington?
